



## Overview excluded companies by controversial activities and behaviour H1 2025

April 2025

The a.s.r. Policy on Responsible Investments is centered on three key policy goals that underline our commitment to contribute to a better world: reducing harm, driving change, or creating positive impact. We exclude companies and countries that do not meet our criteria for controversial activities or behavior. The assessment of companies is based on two ESG data providers: MSCI ESG and Moody's.

Companies with controversial behavior in the form of very severe, repetitive and unmediated breaches of UN Global Compact principles are engaged or excluded from a.s.r. portfolios.

Companies involved in controversial activities such as weapons\*, tobacco, gambling production or distribution; nuclear energy when representing more than 50% of revenues; conventional\*\* and unconventional (>5% revenue) oil & gas extraction and production; coal mining and expansion plans; unsustainable palm oil and timber production and distribution. \* a.s.r. excludes the production, wholesale, and retail of civilian firearms and ammunition, the involvement in the production of whole weapon systems, delivery platforms, or components of controversial weapons, and the production of conventional weapon systems.
